**“CUSTOMER”** - means for the purposes of this Agreement all public schools as defined and registered in terms of the South African Schools Act, 84 of 1996, and all public Further Education and Training Institutions as defined and registered in terms of the Further Education and Training Act, 98 of 1998 and who have completed the request form.

## **TERMS AND CONDITIONS**

The following terms and conditions will be applicable to any discounts granted in terms of Section 73 of the Electronic Communications Act, 36 of 2005, to all public schools and public further education and training institutions who qualify and are registered in terms of the South African Schools Act, 84 of 1996 and the Further Education and Training Act, 98 of 1998:

1. By completing this request form the Customer accepts the terms and conditions as set out in this Agreement and confirms that Telkom will be entitled to suspend any discount granted on the basis of this request form if any of the information provided in terms of this request form is incorrect or false or if the Customer, for whatever reason, is no longer registered in terms of the above-mentioned Acts.
2. Telkom will be entitled to suspend the discounts if the Customer, for whatever reason, uses the services on which the discounts are granted for any commercial benefit for itself or a third party and therefore accepts that the services may only be used by the specific public school or public further education institution and no other person whatsoever may use or benefit from the use of such services.
3. The 50 % discount will be granted on the standard Telkom call charges for telecommunication calls to Internet Service Providers that are licensed in terms of the Electronic Communications Act, 36 of 2005 (EC Act), which originate in and terminate on Telkom’s network and charges levied by Telkom Internet for Internet services, including, where applicable, charges for any equipment used in association with such services.
4. The 50 % discount will not be granted on any special tariffs, any special discount packages or any special call packages to which the Customer subscribes or may subscribe to.
5. The 50 % discount will be granted from the date of receipt of the duly completed request form and relevant documentation.

6. It is the Customer's obligation to inform Telkom of any deregistration in terms of the above-mentioned Act and Telkom reserves the right to verify from time to time the Customer's registration in terms of the South African Schools Act or in terms of the Further Education and Training Act.

7. By completing this request form this undertaking will not replace any existing agreements between Telkom and the Customer in terms of which the service/s is provided and this request form and terms and conditions are only applicable to the discount on services already rendered in terms of an existing agreement/s.
